Third Request For Proposals (RFP3)
(Issued: January 5, 2006; Proposals due: February 25, 2006)

The Ann Campana Judge Foundation announces its third Request For Proposals (RFP3) with a proposal due date of February 25, 2006. For this funding cycle, each proposal will be limited to a maximum of **\$5,000** from the ACJF. Projects supported during this funding cycle must have a start date no later than August 1, 2006 and an end date no later than December 31, 2007. Proposals that leverage funds or include in-kind contributions from other organizations/individuals are especially encouraged; such funds/contributions and their sources must be listed. Proposals from student organizations are especially sought.

A total of 7 awards (\$5,000 each) in two separate categories, listed below, will be made. A proposal must indicate that it is being submitted for *one* of the following *two* categories. An organization may submit one different proposal in each category.

- 1) **NGWREF Awards.** The National Ground Water Association (www.ngwa.org), through its 501(c)(3) foundation, the National Ground Water Research and Educational Foundation (NGWREF), has made it possible for the ACJF to fund four projects at \$5,000 each. These projects ***must deal with the development of a potable water supply from ground water, obtained from a drilled or dug well.*** Applicants wishing to submit proposals for one of these awards must check “NGWREF Award” on the proposal cover page.
- 2) **Regular Awards.** The ACJF has allocated \$15,000 to fund three projects at \$5,000 each. These projects must deal with water supply or sanitation, as distinct from the requirements of the NGWREF Awards. Applicants wishing to submit proposals for one of these awards must indicate such on the cover page.

Please refer to the [Guide to Proposal and Report Submission](#) for complete information and guidelines. **Note that proposals not submitted in accord with the submission guidelines nor with all information requested will neither be reviewed nor returned for revision.** The ACJF is unable to “pre-review” a proposal to ensure that it is complete, but prospective proposers may contact the ACJF (via email only) to see if a particular project is acceptable – send a 500-word (maximum) message to acjf@acjffoundation.org. Note that the ACJF does not support scientific research; travel to workshops, conferences, and symposia; data collection projects; or projects in developed countries.

Previous awardees who have not completed their projects or who have not submitted their final reports may submit a proposal, but new awards will not be made until previous projects are completed and final reports submitted. Awards will be made only to individuals or organizations based in the USA or Canada. Projects can be conducted in any developing or low-income country, as defined by the World Bank (www.worldbank.org) or similar group, or in any country with a USAID mission (www.usaid.gov/locations/missiondirectory.html).
